BYLAW 4-2016

A BYLAW TO ESTABLISH THE RESTRICTIONS FOR MOBILE HOMES WITHIN THE VILLAGE OF LOREBURN

The Council of the Village of Loreburn, in the Province of Saskatchewan enacts as follows:

- 1. That mobile homes within the Village of Loreburn are a discretionary use according to the Village of Loreburn Zoning Bylaw #2-2013 and must be approved for placement by Council.
- 2. And that all mobile homes built more than 20 years prior to the current year must be inspected by the Village's building inspector, prior to Council considering the moving permit.
- 3. All permanent structures are subject to Village of Loreburn Building Bylaw #4-2014.
