POLICY

Title: Municipal Elections Policy

Effective Date: August 12, 2020

Purpose:

To provide guidance regarding Municipal Elections for procedural items that are not otherwise determined or regulated by *The Local Government Election Act*, 2015.

General Procedure:

- 1. Remuneration shall be:
 - Returning Officer (RO): \$175.00
 - Poll Clerk (PC): \$125.00
- 2. Remuneration rates:
 - Include all applicable training, set up, clean up and election day polling hours.
 - Are not payable to municipal staff during regular office hours, but are payable at a rate of \$15/hour for work outside of regular office hours.
 - Do not include the Advance Poll. Advance poll payment is paid hourly at the rate of \$15/hour.
- 3. Advanced Poll is set by the Returning Officer and shall be held at a date and time, subject to *The Local Government Election Act*, 2015 and accompanying regulations, that also aims to be of the most benefit to the community for not less than 3 hours and not more than 5 hours, and held between the hours of 7 am and 9 pm.
- 4. The Polling Station shall be set at a wheelchair accessible location capable of hosting the election comfortably and with a high degree of public visibility. Preference for location is in the following order subject to location, logistics, accessibility and availability: Loreburn Town & Country Centre or Loreburn Arena.
